How to contact the appropriate authority

What data do we collect?

Vogue Singapore collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Personal preferences to topics relating to fashion, beauty and lifestyle

How do we collect your data?

You directly provide *Vogue* Singapore with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email
- Use or view our website via your browser's cookies

How will we use your data?

Vogue Singapore collects your data so that we can:

- Process your order, manage your account
- · Email you with information on other products, events and services we think you might like

If you agree, *Vogue* Singapore will share your data with our partner company, Indochine Media, so that they may offer you their products and services.

When *Vogue* Singapore processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Vogue Singapore securely stores your data on our server.

Vogue Singapore will keep your personal particulars for the lifetime of the publication. Once this time period has expired, we will delete your data.

Marketing

Vogue Singapore would like to send you information about products and services of ours and brand partners that we think you might like. These partners include fashion, beauty and lifestyle brands.

If you have agreed to receive such information, you may always opt out at a later date.

What are your data protection rights?

Vogue Singapore would like to make sure you are fully aware of all of your data protection rights. Every

user is entitled to the following:

The right to access—You have the right to request Voque Singapore for copies of your personal

data. We may charge you a small fee for this service.

The right to rectification—You have the right to request that Vogue Singapore correct any

information you believe is inaccurate. You also have the right to request Vogue Singapore to complete information you believe is incomplete.

The right to erasure—You have the right to request that Voque Singapore erase your personal

data, under certain conditions.

The right to restrict processing—You have the right to request that Voque Singapore restrict

the processing of your personal data, under certain conditions.

The right to object to processing—You have the right to object to Vogue Singapore's

processing of your personal data, under certain conditions.

The right to data portability—You have the right to request that Vogue Singapore transfer the

data that we have collected to another organisation, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these

Cookies are text files placed on your computer to collect standard Internet log information and visitor

behaviour information. When you visit our websites, we may collect information from you

automatically through cookies or similar technology.

How do we use cookies?

Vogue Singapore uses cookies in a range of ways to improve your experience on our website, including:

- Keeping you signed in
- Understanding how you use our website

What types of cookies do we use?

There are a number of different types of cookies and our website uses the following:

- Functionality—Vogue Singapore uses these cookies so that we recognise you on our
 website and remember your previously selected preferences. These could include what
 language you prefer and location you are in. A mix of first-party and third-party cookies are
 used.
- Advertising—Vogue Singapore uses these cookies to collect information about your visit to
 our website, the content you viewed, the links you followed and information about your
 browser, device and your IP address. Vogue Singapore sometimes shares some limited
 aspects of this data with third parties for advertising purposes. We may also share online data
 collected through cookies with our advertising partners. This means that when you visit
 another website, you may be shown advertising based on your browsing patterns on our
 website.
- IP address and more information—Information about your geographical location, IP address, type of browser and your device's settings of the operating system when you access our website or mobile app.
- **User activity**—Information regarding your user activity on your device, including web pages and mobile apps visited or used.

How to manage cookies

You can set your browser to not accept cookies and <u>www.allaboutcookies.org</u> tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
